### Q&A With Jennifer Patti, BROWARD EDUCATION

What prompted you to choose a paralegal career? I didn't want to be a lawyer. My love is research and writing, but I wasn't comfortable with public speaking. I understood and appreciated the distinction between the roles of a paralegal and an attorney, and that line should never be blurred. In my "early" years, I had an internship that had me questioning whether I wanted to even be in the legal field. I realized the value in learning from the "questionable" lawyers so I appreciated what a good attorney can do.

How has your membership in SFPA benefited you? Two ways: 1) I found my current position on the SFPA employment page. I was hired within 72 hours. I had been applying to jobs on other classified boards for 3 weeks and my current position was not posted on those boards. 2) You never feel alone. I know I can turn to anyone in SFPA and get assistance.

What do you see as hot trends in the paralegal industry? The electronic age is overwhelming some firms and they are looking for employees who were raised with this technology. Having an employee who can update your webpage/blog etc., is the new "in" thing.

If someone contemplating a paralegal career asked you for career advice, what would you answer? Be realistic. Some firms don't understand the distinction between a legal assistant and a paralegal, let alone a paralegal with a bachelor's vs. a paralegal with a certificate. Having years of experience on the job is usually more valuable than the bachelor's. I believe in working your way up like most other fields. This field is not one for instant gratification, but can be extremely gratifying once you find the right fit.

To what do you attribute your success as a paralegal? Teachers who taught me never to speak or write anything you can't back up.

What is the most important step a paralegal can take to keep his or her career interesting? Attend CLE classes that appeal to you, even if they are not in your field.



#### What prompted you to choose a paralegal career?

The ability to express coherent and complete ideas with brevity will separate you from the pack. It's too easy for people to ramble off in e-mails and send way too many e-mails.

What is the most important step a paralegal can take to keep his or her career interesting? Branch out and insist on exposure to different procedures and legal subjects. Like any job, it can become a routine.

What is your favorite part of your job? The satisfaction of pulling through when your plate is full.

I wanted a professional certification that the legal community would acknowledge; that would signify that I was capable of providing the highest quality of service as a paralegal.

The Certified Paralegal examination challenged my knowledge of specific areas of law, reading comprehension, analytical skills and writing abilities. It required me to demonstrate an understanding of the structure of the legal system, the purpose of the law and its procedures. The most challenging aspect of the examination was the Judgment and Analytical portion, which required analysis of a research request, finding applicable law, and writing a responsive memorandum.

The review course offered by South Florida Paralegal Association was extremely helpful. The individual classes covered each subject in the NALA Manual for Paralegals, and included a mock examination which simulates the test environment. I am honored that I have acquired my certification and plan to take a more active role in the legal community as a certified paralegal.

### **DEFINING A PARALEGAL's role**



#### **Defining a paralegal:**

Bureau of Labor Statistics defines paralegals or legal assistants as individuals that "assist lawyers by investigating facts, preparing legal documents, or researching legal precedent...conduct research to support a legal proceeding, to formulate a defense, or to initiate legal action."

American Bar Association: "A legal assistant or paralegal is a person, qualified by education, training or work experience who is employed or retained by a lawyer, law office, corporation, governmental agency or other entity and who performs specifically delegated substantive legal work for which a lawyer is responsible."

### National Federation of Paralegal

Associations: A Paralegal is a person, qualified through education, training or work experience to perform substantive legal work that requires knowledge of legal concepts and is customarily, but not exclusively, performed by a lawyer. This person may be retained or employed by a lawyer, law office, governmental agency or other entity or may be authorized by administrative, statutory or court authority to perform this work. Substantive shall mean work requiring recognition, evaluation, organization, analysis, and communication of relevant facts and legal concepts."

Which definition fully states what we believe to be a paralegal? What definition should associations adopt? Which definition will the Courts accept? Each definition stated above stresses the importance of education, supervision by an attorney and substantive legal work (that is non-clerical in nature) that would otherwise be completed by an attorney.

#### What a paralegal cannot do:

- 1. Paralegals must communicate to the client that they are not an attorney;
- Paralegals cannot be partners in a law firm:
- 3. Paralegals cannot share legal fees;
- Paralegals are permitted to have business cards, their name on firm letterheads and sign correspondence as long as it has the appropriate designation;
- Paralegals cannot give legal advice; and/or;
- Paralegals cannot sign pleadings, appear in court, set fees or receive bonuses that are tied to a particular case.

### What is the difference between a paralegal and a legal document assistant?

According to the Alliance of Legal Document Assistant Professionals, "A Legal Document Assistant (LDA) is a non-attorney, qualified by experience and education, who is authorized to provide self-help legal services to a consumer who is representing himself or herself in a legal matter. A Paralegal is authorized by law only to perform substantive legal work for a licensed attorney, law firm or in-house legal department. Paralegals are not permitted to provide services directly to members of the public." (http://www.aldap.org/ethics.htm)

Who should clearly define paralegals? The Courts, the States ... should there be statutes and legislation or reliance upon case law? Who will ultimately respond to these questions?

# What are the educational differences and requirements to sit for the following various tests:

National Association of Paralegals - the Certified Paralegal/Certified Legal Assistant Exam (CP/CLA) and the Advanced Paralegal Certification (APC); National Federation of Paralegal Associations (NFPA) - the Paralegal CORE Competency Exam (PCCE™) and the Paralegal Advanced Competency Exam (PACE®); American Alliance of Paralegals, Inc. (AAPI) - the American Alliance Certified Paralegal application (AACP); National Association of Legal Secretaries (NALS) - the Professional Paralegal Exam (PP)?

Which test is the right test? Will any of the tests be approved by the Courts to certify a paralegal? Who will monitor the UPL requirements of paralegals? States like Florida, Ohio and North Carolina are some of the few that have Certification programs through their state bar associations. States like Pennsylvania, New Jersey and Delaware have Certification programs through their state or local paralegal associations. Other states like Florida, Ohio, Kentucky and North Carolina are some of the few that have Certification programs through their state bar associations.

There are three (3) types of regulation: Registration, Certification and Licensure. Why is regulation important? As attorneys confront challenges in their daily practices to provide quality legal services to their clients, attorneys need to be assured that the paralegals they employ to assist in their practice are better educated and aualified to provide legal services. Members of the public indirectly rely on the work performed by paralegals and many times directly rely upon information given to them by paralegals. Paralegals should know and understand their ethical duties, their limitations under the Unauthorized Practice of Law statutes, and meet minimum standards of paralegal competency. Although most states with a regulatory scheme have a voluntary program, it does give the attorney a muchneeded benchmark to assist with hiring practices and hopefully reduce ethical violations, unauthorized practice of law violations, and malpractice claims. Regulation will not prevent attorneys from hiring any nonlawyer as a legal assistant or paralegal but it will help attorneys to identify qualified candidates and allow the attorney to publicize the employment of a certified or registered paralegal

There seem to be more questions than answers; more gray areas than clear black and white ones. How can individuals hold themselves out as professional paralegals when no one knows or even understands what that role means and entails? What should the requirements be? Should someone right out of school hold the same position and salary recommendation as someone who has been in the legal field for over ten (10) years and is just now getting the recognition they deserve? What are the educational requirements, degrees or certificates which should determine becoming a paralegal?

Some of the benefits for employers to utilize paralegals are reduced costs to clients, lower legal fees, increased client contact, court approved paralegal fees, pro bono opportunities, liaison with Court personnel, proficiency in electronic filings, specialized services and competitiveness in legal community (American Bar).

Some of the issues facing the paralegal profession include outsourcing, disbarred/suspended attorneys working as paralegals, cutbacks, work satisfaction and growth/promotion opportunities. However, according to the Bureau of Labor Statistics, "The number of labor for paralegals is

# "The number of jobs for paralegals is expected to grow much faster than the average for all occupations through 2018.

Law firms will hire more paralegals to help lawyers prepare their cases. More people and businesses will need legal help. Many people like these jobs, so new workers are expected to face competition."

A student and/or a working paralegal should be interested in these issues and many of the other issues facing the paralegal profession. A way to do that is to make professional development a part of your daily program or schedule.

#### **Remember VIPER:**

- Volunteer for pro bono or community service projects or assignments
- Involve get involved in a committee or group with the local paralegal association
- Participate in a luncheon or special event in the legal community or local paralegal association
- Educate continue your legal education through seminars or conferences
- Respect continually have respect for your chosen career

### E-EVERYTHING!

It seems every month there's a new "e" rule, whether state or federal, and in each jurisdiction.

Regardless of what field you work in, or plan to work in, keep your eye out for these rules:

Florida Rule of Judicial Administration 2.516, the "e-Service" Rule, effective

September 1, 2012

### Florida Rule of Judicial

Administration 2.525, the "e-Filing" Rule, effective October 1, 2013 for Civil, Probate, Small Claims, and Family Law cases. The Rule is effective October 1, 2013 for Criminal, Traffic, and Juvenile cases.

Broward County Pilot Program for Acceptance and Service of Electronic Agreed Orders and Court Documents pursuant to Florida Rule of Judicial Administration 2.516, effective December 1, 2012 for specific cases and judges. Using the online scheduling system, attorneys can file certain Agreed Orders to the judge and opposing parties. Once executed (or denied) by the judge, the Order will be emailed back to the attorneys of record. More information can be found at:
